- to hold harmless the RRC, the Regional Municipality of Wood Buffalo (“**RMWB**”), their respective directors, officers, employees, agents, advisors, and elected officials from all claims, liability and costs related to all aspects of the items to sell;
- that it shall not be entitled to claim against the RRC, the RMWB, their respective directors, officers, employees, agents, advisors, and elected officials on grounds that any information, whether obtained from the RRC or otherwise, regardless of the manner or form in which the information is provided is incorrect or insufficient;
